The major part of legal acts listed in the current issue relate to the period from August to December 2003.

Among new legal instruments are federal laws "On General Principles of Organisation of Local Government in Russian Federation", "On Lotteries", "On Mortgage-backed Securities", "On Principles of State Regulation of Foreign Trade Activities", "On Special Protective Antidumping and Compensatory Measures for Import of Goods", "On Exchange Regulation and Exchange Control", a number of legal instruments introducing amendments and additions to Part Two of Russian Federation Tax Code.
