The major part of legal instruments listed in the current issue relate to the period from April to July 2003.

Among new federal laws are the Customs Code of the Russian Federation, Federal laws "On Individual Private Farm", "On Subsidiary Household Plot", "On Transport And Forwarding Activities".

Substantial amendments and addenda are introduced into the Russian Federation Tax Code, Federal Constitutional Law "On Arbitration Courts", Federal laws "On General Principles of Organisation of Legislative (Representative) and Executive Authorities of Russian Federation Subjects", "On Turnover of Land Involved in Agricultural Production", "On State Registration of Legal Entities", "On State Registration of Rights to Real Estate and Transactions Therein", "On Agricultural Cupertino".

Among Russian Federation President's decrees distinguish themselves the decrees "On Measures to Conduct Administrative

Reform in 2003-2004", "On Additional Measures to Improve Financial Conditions of Agricultural Producers", "On Public Council for Investing Pension Savings*.

Among the Russian Federation Government's normative legal acts could be emphasised the Decree "On Work-books", documents related to activation of reforms in energy sector, railroad transport, housing and communal services, to continuation of privatisation of federal property, placement of temporarily uncommitted pension savings, and also decisions defining the principles of state policy in the sphere of utilisation of mineral resources and using of subsoil segments, and the concepts of actions on labour market, of development of transboundary Cupertino, internal water transport, market of liquefied gas for households.

The publication also covers a number of departmental documents.
